1	Application form to be filled in completely and signed by the applicant. (<i>Application Form of Child under 18 should be signed by both the Parents</i>)		
2	One Recent passport-size photographs in colour with white background		
3	The Passport should be valid for atleast six months beyond the intended duration of stay in the Schengen territory.		
4	Prior Approval from the Greek Authorities.		
5	Marriage Certificate duly attested by Ministry of External Affairs, New Delhi with an Apostile Sticker.		
6	Marriage Photographs & Marriage card.		
7	Police Clearance Certificate duly attested by Ministry of External Affairs, New Delhi with an Apostile Sticker. The certificate should not be older than six (06) months.		
8	Medical Certificate duly attested by Ministry of External Affairs, New Delhi with an Apostile Sticker. In the medical certificate it should be mentioned that the applicant is not suffering from cholera, tuberculosis, yellow fever, plague and any other transmitting disease as defined by the World Health Organization and is not pregnant. The certificate should not be older than six (06) months.		
9	Ration Card (Original with English translation) duly attested by Ministry of External Affairs, New Delhi with an Apostile Sticker.		
10	Matriculation Certificate or Middle School Board Certificate or School Leaving Certificate containing the Date of Birth.		
11	Divorce Judgment & Decree from former Spouse, if applicable.		
12	Passport photocopy (recent & cancelled) of all the pages of the Sponsor.		
13	Bank Statement of the Sponsor from Greece for the last three (03) months.		
14	Income Tax Returns of the Sponsor from Greece for the last three (03) years and duly authorized by Greek Public Financial Service called DOY.		
15	Rent Agreement or Proof of Residence duly authorized by Greek Public Financial Service called DOY.		
16	Original certificate from the Social Security (called IKA) of the inviter mentioning that his family medical expenses will be covered.		
17	Employment contract letter of the sponsor or any other proof of Employment.		
18	Family Status Certificate mentioning the name of spouse and children. The Family Status Certificate must state that the inviter is still married to the applicant and that their children are the following. The certificate can be issued either from India or Indian Embassy in Athens. If the certificate is issued from India than it should be duly authorized by Ministry of External Affairs, New Delhi with an Apostile sticker. The certificate should not be older than six (06) months.		
19	In case of Minor, <ul style="list-style-type: none"> ○ Birth Certificate (with English Translation) duly attested by Ministry of External Affairs, New Delhi with an Apostile Sticker. ○ Medical Certificate duly attested by Ministry of External Affairs, New Delhi with an Apostile Sticker. In the medical certificate it should be mentioned that the applicant is not suffering from cholera, tuberculosis, yellow fever, plague and any other transmitting disease as defined by the World Health Organization ○ Police Clearance Certificate duly attested by Ministry of External Affairs, New Delhi with an Apostile Sticker. 		
20	Previous passport may also be required by the Embassy.		

Note: Applicant would be asked for additional documents or may be called for an Interview if desired by The Embassy of Greece.
